Multiple Student Discount

In order for families to receive the multiple student discount, children must be related and living in the same household.

Financial Aid

Financial assistance is available to those who qualify based on income. To apply for Financial Aid, please complete the following items:

1. Pay the \$165 Registration Fee and fill out an *Application for Enrollment* for 2022-2023
2. Fill out an *Application for Financial Aid* (proof of income required)

Please note: Donor contributions given toward financial aid are limited and will be distributed in the order applications are received. Financial aid does not cover registration fees, extended care or any additional fees not included with monthly tuition payments listed above. Families must apply for Financial Aid each year. Payment Options

Tuition payments are managed by Quickbooks. Tuition payments are made on the 15th or last business day of the month. Each family is provided a Tuition & Enrollment Contract, which shows the total tuition due for the upcoming school year.

Option 1: Annual Payment One payment in full is due in August 2023

Option 2: Monthly Payment Ten equal payments each are due on the 15th or 30th/31st each month from August 2022, to and including, May 2023.

Late Fees

A \$40 late fee will be charged to the family the day after the due date has occurred. The family has 15 days to resolve the late tuition. The St. Paul Tuition Review Board will contact the family to discuss payment options. If the payment is not received within 30 days of the due date, the child(ren) will not be able to attend school until the tuition payment is resolved.

Extended Care Program

Extended Care fees are billed monthly per student. No multiple child discounts are given. Families needing only one day of extended care and early dismissal days will be charged \$10 per student per day. Siblings of students in extracurricular activities will be charged for extended care attendance. ***Child Care Initiative accepted for extended care ONLY. In order to attend the Extended Care program, students will be charged \$10.00 per student, per program.***

Before Care: \$35 per month
7:00 am to 8:15 a.m.

After Care: \$55 per month
3:15 pm to 6:30 p.m.

Both: \$85 per month
Daily rate: \$10

Continuous Enrollment

Once your children are enrolled, they are continuously enrolled until graduation from St. Paul or until the family follows an opt-out procedure. Students are considered part of St. Paul until they graduate. Current families must update their information in the main office each year (new phone number, new address, etc.). New applicants must complete the Registration Packet.

- I hereby opt into continuous enrollment. This means that my children who are enrolled at St. Paul Lutheran School will return to St. Paul every year unless I tell the school otherwise.
- I understand that I have until April 1 to notify the St. Paul Main Office of any changes in my plans of enrollment for my children.
- I understand that the Continuous Enrollment Fee will be paid in April of each year. It is a non-refundable fee paid each year in order to save my child's seat in the classroom.

We have created a series of Frequently Asked Questions (FAQs) to help our families understand how this process works and to anticipate questions you might have. Please read over the various FAQs to better understand the details.

Withdrawal Process:

If I wish to withdraw my children prior to April 1, I must contact the main office and complete the withdrawal form. If I withdraw:

- After April 1 up to and including June 1, no amount of tuition or fees will be due, with exception to the Continuous Enrollment Fee
- After June 1 up to and including August 1, parents or guardians are financially responsible for 50% of annual tuition.
- After August 1, parents or guardians are financially responsible for 100% of annual tuition.
